## NOTICE AND REGULATIONS OF MYTATA INGLESE SERVICES

MyTata Inglese is a nonprofit association that offers a variety of services related to foreign language learning.

Membership in the association can be obtained by submitting an application form, which can be found on our website or obtained at the association's office.

The registration form must be completed in its entirety and signed by the parent or guardian who intends to become a member of the association, along with the privacy policy form. Both documents, along with a copy of the identification document, should be submitted to the association. If both parents have parental authority, the second form must be signed by both individuals.

Membership acceptance is subject to the association's approval of the application.

The payment methods and terms for the membership fee are indicated in the registration form.

Within the registration form, the applicant must indicate the desired service among the following options.

## **TEACHERS**

MyTata Inglese connects families with a community of teachers who communicate with children exclusively in their native language.

The association organizes meetings between families and teachers even before the registration request.

Once the parent becomes a member, teachers commit to conducting weekly meetings. In the event of illness, the meeting is not canceled but only postponed.

To ensure that the service runs smoothly, both parties must communicate doctor's appointments and any exams at least two weeks in advance.

Vacation periods must be communicated by both parties at least one month in advance.

Parents and teachers must work together to ensure that children do not use mobile devices during the sessions. If necessary, the use of phones should be limited and contextualized (e.g., listening to songs).

Parents and teachers must work together to provide a dedicated space for the sessions without the presence of parents, grandparents, or other family members.

The association acts solely as an intermediary between families and teachers and does not decide on the economic and tax aspects.

To declare the teacher's activity, you can contact one of the following: a certified public accountant, the INPS, or the CAF CISL.

For insurance, we recommend contacting Parenti Tommaso at Via dei Rossi, 88, Scandicci (Florence).

Summer Camp Regulations

The MyTata Inglese association organizes summer camps for children and/or young men and women who make use of the association's services.

The program for the summer camps can be obtained at dedicated events organized by the association.

The summer camps are governed as follows:

- 1) Registration for the Summer Camp is done through the appropriate form available for download on the association's website or obtainable at the association's office.
- 2) The form must be completed in its entirety and signed by the individuals exercising parental authority over the participating minor and submitted to the association as indicated.
- 3) Applications will be accepted in the order of their arrival, as attested by the association. Once the maximum number of participants is reached, registrations will be closed.
- 4) Registration is confirmed upon receipt of payment of the participation fee within 3 business days of the association confirming receipt of the application, via bank transfer, check, or cash.
- 5) A minimum of 10 participants must be reached; otherwise, the summer camp will be canceled, and the fees will be refunded.
- 6) Registration for the Summer Camp entitles you to a 30% discount on registrations for subsequent weeks.
- 7) In the event of registration cancellation up to 20 business days before the start of the summer camp, the entire participation fee paid will be refunded. Otherwise, the association reserves the right to retain 30% of the participation fee as a penalty.
- 8) In the event the summer camp is interrupted for proven health reasons, a pro-rated portion of the fee for the unspent period will be refunded.
- 9) During the summer camp, participants must follow the instructions of the teaching staff and must not leave without the organizers' authorization.
- 10) Participants must bring a backpack, cap, towel, slippers, sandals, mosquito repellent spray, and sunscreen. In case of rain, they must bring a waterproof jacket.
- 11) Participants are covered by accident and RCT insurance contracted at the time of registration with MyTata Inglese.

- 12) The association is not responsible for theft or loss of personal belongings during the summer camp.
- 13) Any material damages intentionally caused by the participants are solely attributable to the individuals responsible.
